MOTION to accept the October 22 minutes as circulated. Moved by Joan Misner. Seconded by Angela Rudolf. No discussion. **MOTION CARRIED.**

FINANCIAL REPORTS

NEW BUSINESS

1. Executive Recommendation - CUPE Local 1099 provides \$100.00 to Members in Need, to a maximum of \$1500.00 before the Winter Holidays. Members in Need to be nominated by fellow members no later than December 15th, 2024.

MOTION to provide \$100.00 to Members in Need, up to \$1,500.00. Moved by Claire Stata. Seconded by Daniel Rose. Discussion included: This is something beneficial we've done for years, increasing the amount last year due to increased need. MOTION CARRIED.

2. Executive Recommendation - Re-schedule the December General Membership Meeting to December 16th or 18th, 2024 at 6:00pm.

UNIT BUSINESS

- 1. St. Albert Public Schools
 - a. Bargaining Update: More than half the membership voted (thank you!) and we are feeling good about going back to the table on Thursday. Wear purple on Thursday! Filed for Mediation already in anticipation of long wait times in the new years.

b. Executive Recommendation - CUPE Local 1099 approve a budget of up to \$15,000.00 for Mobilization Budget. This will be used to organize, plan, and buy materials for Member and Community Engagement Events and Activities. We will be submitting a Cost Share proposal/request with CUPE National to help cover some of these costs.

MOTION to accept the Executive Recommendation for CUPE Local 1099 to approve a Mobilization Budget of up to \$15,000. Moved by Karin Dowling. Seconded by Hope Lagaden. Not anticipating spending the maximum, but want to be prepared. CUPE National will contribute a portion. The funds will assist with book offs, advertising, communication, rallies, etc. We are anticipating a tough bargaining season, and our participation in the Waging Ahead campaign would benefit us as we move forward. We don't yet have a strike fund but should we get there, funds for that would also come from CUPE National. Concern expressed that many members may suffer if we go on strike. Is there a cut-off for spending? No, but New Memberships grow our coffers and we have two new units coming onto our books. September and October often look like we took a hit after the summer months, but things tend to level out over the year. Reminder that Heidi's wages are in support of the union and not exorbitant. MOTION CARRIED.

- c. Workplace Safety Committee Still seeking 2 more members to join the Committee, mainly to serve as alternates and assist in communicating. The purpose is to meet with the Employer to discuss safety needs around violent students and how to address these needs.
